MOAA Purpose and History

MOAA is the nation's largest and most influential association of military officers. It is an independent, nonprofit, politically nonpartisan organization.

With more than 380,000 members from every branch of service - including active duty, National Guard, Reserve, retired, former officers, and their families - we are a powerful force speaking for a strong national defense and representing the interests of military officers at every stage of their careers.

MOAA's highest priority is providing first-class service to our members. We are the leading voice on compensation and benefit matters for all members of the military community. We provide expert advice and guidance to our members.

Purpose

While the association does advocate a strong national defense, it does not, as an association, become involved in matters pertaining to military strategy or individual weapons systems of the various services. The association's board of directors has long believed that such decisions can be made only by those who have all of the facts available to them: today's actively serving military leadership.

The association plays an active role in military personnel matters and especially proposed legislation affecting the career force, the retired community, and veterans of the uniformed services. MOAA's overarching goals are captured in its resolutions, which reflect the views of the entire membership. The membership provides input and votes on resolutions every two years (on even years).

While MOAA is permitted by law to lobby - and does so actively - its status as a tax-exempt veterans organization precludes it from participating in political activities, which are defined as intervening directly or indirectly in any political campaign on behalf of or in opposition to any candidate for public office. Stated briefly, the association may advocate issues, but it may not advocate the election or defeat of particular candidates or political parties.

History

MOAA was founded in Los Angeles, Calif., on Feb. 23, 1929. The first leaders of the association hoped that by joining to-

New Copays for TRICARE Pharmacy Customers

New copayments for prescription drugs covered by TRICARE will go into effect soon. The Fiscal Year 2013 National Defense Authorization Act requires TRICARE to increase



copays on brand name and non-formulary medications that are not filled at military clinics or hospitals. There is no increase to copays for generic medications. Increases will be effective sometime in February, depending on when system changes can be made, and the publication of a required Federal Notice.

TRICARE Pharmacy copays vary based on the class of drug and where beneficiaries choose to fill their prescriptions. The copay for generic medications stays at \$5 when a prescription is filled at a network pharmacy. There is no co-pay when generic prescriptions are filled through TRICARE Home Delivery. The new copay for a 30-day supply of a brand name medication purchased at a retail network pharmacy will be \$17, up from the current \$12. Beneficiaries using TRICARE Home Delivery will pay \$13 for brand name drugs, up from \$9. However, the Home Delivery price is for a 90-day supply.

The greatest change in copays applies to non-formulary medications. The \$25 copay for these drugs increases to \$44 at retail pharmacies and \$43 through Home Delivery. The TRICARE Uniform Formulary is a list of all the medications TRICARE covers.

For fiscal 2014 and beyond, the new law directs that copays increase annually by the same percentage as retiree cost-of-living adjustments. In years when a COLA increase would total less than a dollar, it will be delayed a year and combined with the next adjustment so increases will always be \$1 or more.

Medicare/TRICARE Physician Payments

On January 1st, the Congress gave final approval to H.R. 8, the American Taxpayer Relief Act of 2012. Included in this "fiscal cluff" legislation was language preventing a 26.5 percent reduction in reimbursements for Medicare/TRICARE physicians that were slated to begin in the new year, and instead maintains payment rates at their current level through December 31, 2013.

Student Veterans Call for In-State Tuition

Everyone from Florida's governor and VA secretary to state lawmakers likes to call Florida the most veteran-friendly state in the nation.

Some veterans are saying, "Okay, prove it."

Student veterans are challenging lawmakers and the governor to pass legislation that would give them a break on college tu-

ition. Almost a dozen states give military veterans in-state tuition waivers even if they've just moved there.

That's the experience of Andrew Napier, who served six years in the Army National Guard and is now applying to medical school at the University of South Florida.

"I'm coming from Kentucky. They were able to give it to the veterans," Napier said. "We have lawmakers there that say, 'Hey, we support veterans," but this is backed up by a law.

Napier is a Pat Tillman Military Scholar. It's a competitive scholarship named after the NFL player who quit his professional football career and joined the military after the 9-11 terrorist attacks. Tillman Scholars are veterans recognized for their academic and military excellence, as well as their ongoing community service and advocacy for veterans.

Napier said it's time for Florida lawmakers to pass in-state tuition for veterans.

"There needs to be substance behind the words that say that 'veteran friendly.' Just to say something is one thing, but actually to act on this is going to be very beneficial to the people not just to veterans but to the community," Napier said.

Bills that would establish in-state tuition for veterans have been proposed previously but never passed. This year, SB260 by Senator Jack Latvala would grant veterans in-state tuition rates.

It's a benefit already extended to active-duty military.

Kiersten Downs, a veteran of the Air Force and New York Air National Guard, is president of the USF student veterans group.

"It's becoming a hot-button issue again," Downs said. "We are talking to student government here at USF who is diligently working to advocate and push this issue for student veterans."

Downs said there are roughly 1,400 veterans and dependents receiving GI education benefits at USF. As a doctoral student, she knows what it's like when those benefits are used up.

"I am a graduate assistant so I do have a tuition waiver at this time," Downs said. "Once that runs out, I will have to pay out-of-state tuition. From my understanding, the only way to get instate is to drop out of school for a year and work and gain the in-state tuition status."

Or like some of her friends, Downs said, the other choice is to leave the state which means a brain-drain of educated and battle tested veterans.

"I have friends who are graduates who are actually moving back to the State of Texas to go to graduate school because of the more friendly veteran friendly environment and in-state tuition offered there," Downs said.

Student veterans are usually older with families looking to put down roots. Napier said they are the kind of residents Florida should try to keep.

"So if Florida wants to be more attractive to veterans and wants to keep people around and have sustainable income, lower that tuition," Napier said.

Neither Downs nor Napier had an estimate on what it would cost to extend in-state tuition to all veterans in Florida. However, both said the cost would be worth it for Florida's future.

Navy: Random alcohol tests for sailors in US

NORFOLK, Va. (AP) — The Navy said Wednesday it will conduct random blood-alcohol tests on its sailors in the United States starting next month, a sign of how concerned the service's leaders have become about the effects alcohol abuse is having on the force.

The tests are part of Navy Secretary Ray Mabus' 21st Century Sailor and Marine Initiative, an expansive program intended to improve the well-being of sailors and Marines after more than a decade at war.

The Marines announced it would carry out its own random alcohol tests last month. While alcohol has long played a part in the Navy's culture, Navy officials stressed they aren't trying to stop sailors from drinking altogether, but are concerned about their health and safety.

The Navy said it will use the blood-alcohol tests to determine whether someone is fit for duty or may need counseling. Any sailor whose blood-alcohol level is .04 or higher when reporting for duty won't be allowed to work. In all 50 states and the District of Columbia, a driver with a 0.08 percent blood-alcohol is considered drunk.

A positive test result for a sailor reporting to work - a reading of 0.02 percent or higher - won't be used to punish sailors. But the Navy said it could be used to refer him or her to a drug and alcohol program adviser.

Adm. Mark Ferguson, vice chief of naval operations, said the random tests could help spot sailors who need support before "an incident occurs due to the irresponsible use of alcohol." He also wrote in a message outlining the new details of the policy to the fleet that the tests will serve as a safety measure and raise awareness among commanding officers of a crew's "culture of alcohol use."

Alcohol is of particular concern because of the role it frequently plays in other destructive behaviors such as suicide and sexual assault. Alcohol also has played a factor in the dismissals of a number of commanding officers in recent years.



gether they could provide assistance and advice to other military officers. This concern for others fostered natural fraternal relations among members from all branches of the uniformed services.

By the beginning of World War II, MOAA's leaders realized that they needed to reorganize and expand to become an effective force on behalf of their members. In what turned out to be a wise decision, MOAA moved to Washington, D.C., in 1944 with a membership of 2,600.

After a membership vote in September 2002, the association changed its name from The Retired Officers Association (TROA) to the Military Officers Association of America (MOAA), on January 1, 2003.

Today, MOAA has grown to a membership of more than 370,000 members and is the country's largest military officers' association. MOAA's purpose also has grown to include career transition assistance, improved member products, military benefits counseling, educational assistance to children of military families (to include enlisted), and strong involvement in military professionalism activities.

"Deterring irresponsible use of alcohol is essential to the readiness of our fleet and ensuring the health and safety of our service members and units," Adm. Bill Gortney, commander of U.S. Fleet Forces, said in a statement.

In a pilot program with 13 commands this past summer, nearly 7,500 sailors were subjected to random alcohol tests. Of those, 87 tested positive for alcohol.

"The test verified that the majority of our service members, who choose to drink alcohol, do so responsibly. It also verified that our commanding officers need a flexible program that serves to increase the Navy's awareness about the impacts of alcohol," Gortney said in a statement.

By May 24, the Navy expects to have hand-held alcohol detection devices available for nearly 2,000 commands.

The 21st Century Sailor and Marine Initiative was unveiled by Mabus in a rare 'all-hands' call aboard a ship in Norfolk last March that was broadcast to sailors around the world. Among other things, it also focuses on preventing suicides, sexual assaults and increasing physical fitness. The Navy has also begun conducting random urine tests for synthetic drug use under the initiative.

Unlike the alcohol tests, those who test positive for synthetic drug use are subject to punishment.
