St Petersburg High School JROTC Program Partner Update

The St Petersburg MOAA Chapter has teamed up with the Raymond James Veterans Inclusion Network (VALOR) to support our five local high school JROTC units. The Raymond James VALOR team is a key advocate for Veteran's education, professional development and community outreach. VALOR represents all service branches, fostering camaraderie, networking,



and community involvement by providing career development, training and outreach opportunities.

Last year, our chapter was selected by VALOR to be a community partner for the next five years. This relationship provides financial resources to support our JROTC engagements and connects us to other veteran support organizations within the VALOR network. For 2024, the VALOR team graciously donated \$10,000 that will be used to cover equipment gaps for each of these high school programs. High school JROTC programs rely on limited school funds and community donations to support material requirements, to include drill team uniforms, rifles, etc. The JROTC unit leaders are providing the Executive Council with a prioritized list of requirements to assist in fund distribution.

We are honored to work with the Raymond James VALOR team and look forward to having them join us at upcoming JROTC award ceremonies so VALOR leadership can see firsthand the impact their support is having on these future leaders.

Since 2018, Valor offers members and allies the opportunity to exchange information and ideas and give back to our community. Currently, many members and allies work closely with a variety of organizations

Did you know that the National MOAA website (moaa.org) has a monthly article in the Surviving Spouse Corner? Every month there is a new article relating to Surviving Spouses and/or those preparing for the future as they grow more "mature".

Previous articles have included: What to Know About National Cemetery Burials, What you Need to Know about Reserve-Component Benefits, and Avoid These Surprises During Your Time of Loss.

In this article I'd like to focus on the Surviving Spouse Virtual Chapter and encourage you to become a member. The article, titled "Join our Virtual Chapter", was written by Gail Joyce. I hope it inspires you to check it out.

"Our virtual chapter provides a place for surviving spouses and surviving spouse liaisons to learn important information, share ideas, and form new relationships with friends who share a common bond. A member recently commented that she got the most useful and import-

ant information from this group that she could not find in other places.

We meet once a month on the third Tuesday of each month; however, we do not meet in November or December due to busy holiday schedules.

Once you join, you will receive a notice each month with a link for joining the meeting. In odd-numbered months, beginning with January, meetings are more formal, with an agenda and a guest speaker.

In even-numbered months, meetings are more informal and are primarily for information sharing. In both meetings, there is always the latest information provided about important advocacy issues that affect spouses, surviving spouses, and families.

In addition, there is a book club that meets once a month on the third Monday of the month. Books are chosen by the participants and include both fiction and nonfiction.

The Surviving Spouse Virtual Chapter, chartered in 2018, began with 10 members and has grown to 250 members from almost every state — but not all 50 yet. Florida and Texas lead the way with the most members.

My morning protein bar wrapper reminds me of two great truths about our human condition: "We are all builders. And we're better when we work together."


These two great truths flow from the Judeo-Christian teaching that ALL humankind is created in the image of God - the Imago Dei.

This image is not understood in a physical sense, rather, our creation in the image of God means that "we are free to make choices: to love, to create, to reason, and to live in harmony with creation and with God." (*The Book of Common Prayer 1979*, p. 845)

In the Judeo-Christian tradition, God created or "built" the universe, our solar system, our earth, the earth's flora and fauna, and the first human beings. We bear the image of this creating and

building God, and we are called to be creators and builders in our various life roles (spouse, parent, sibling, employee, manager, volunteer, etc.) as well.

With my role as a builder in mind, I'm reminded of one question in Rotary International's Four Way Test "of the things we think, say, and do:" Will it build goodwill and better friendships? In other words, how can we build up, raise up, and encourage those around us? When we are a "lifter" of those around us (thank you, John Maxwell), we model the image of god.



"We are all builders. And we're better when we work together." When we work together, we model the Christian understanding of God as Father, Son, and Holy Spirit - the Trinity. The Trinity worked together in Creation and we model the Imago Dei when we work and play well with others to reach a common goal or purpose at work, in play, or as a member of MOAA working as advocates and supporters for our total military family.

O God, you made us in your own image to love, to create, to reason, and to live in harmony with you, one another, and your creation: Look with compassion on the whole human family; take away the arrogance and hatred which infect our hearts; break down the walls that separate us; unite us in bonds of love; and work through our struggle and confusion to accomplish your purposes on earth; that, in your good time, all nations and races may serve you in harmony around your heavenly throne. A Look Back...



A Look Back to 12 March 1947

In a dramatic speech to a joint session of Congress, President Harry S. Truman asks for U.S. assistance for Greece and Turkey to forestall communist domination of the two nations. Historians have often cited Truman's address, which came to be known as the Truman Doctrine, as the official declaration of the Cold War. In February 1947, the British government informed the United States that it could no longer furnish the economic and military assistance it had been providing to Greece and Turkey since the end of World War II. The Truman administration believed that both nations were threatened by communism, and it jumped at the chance to take a tough stance against the Soviet Union.

Legislative Action

Greetings - fellow Officers. I would like to begin this newsletter starting with our State government. In Florida, there is an estimated Veterans population of 1.4 million. We also have a dedicated Florida Veterans organization at the state level – Florida Department of Veterans Affairs (FDVA). It has an informative website as well, where you can take note of the benefits to veteran, retired and former military officers which accrue because of Florida residency.

I want to highlight for you the proposed 2025-2026 Florida state budget for FDVA totaling \$17.5 million.

The Governor's Focus on Fiscal Responsibility Budget invests \$12.3 million to support capital improvements for the State Veterans' Nursing Homes. The budget includes \$3 million for renovations of the 120-bed Baldomero Lopez State Veterans' Nursing Home in Land O' Lakes, which opened to residents in 1999.

The budget also invests \$2.2 million to support enhancing safe and secure medication management for residents in State Veterans' Homes.

The Governor's Budget continues a \$2 million investment to assist veterans in securing meaningful skills-based employment, provide employers a skilled talent pipeline, and to assist veterans in creating and operating a small business.

The budget includes \$1 million for the Veterans Dental Care Grant Program, which expands access to dental care services for veterans through committed nonprofit organizations.

As you can see from the above, the focus is on the staterun veterans residence facilities as well as training for skill-based employment and improving dental care.

I recommend that you encourage our state representatives to implement the proposed budget which fills a gap that local government and the VA is hard pressed to fill. Here they are:

Our 119th Congress has now been in session for nearly two months. Please take note of the fact that nearly 100 members have military experience, the largest number in eight years. Nearly 1/3 have served since January 2000. Naturally, they represent a significant shift from those of us who served prior to that time.

Our MOAA leadership has laid out priorities for the Congress to consider:

- ☐ Improving military housing for those currently serving. Curtailing the wait times for veterans who were exposed to toxic chemicals to ensure they receive care and benefits. Passing a new Military Spouse Hiring Act to increase spouse employment opportunities.
 - Enhancing stability in DoD health care.
 - o Improving care-giving support within the VA system.

For your information, the key House and Senate Committees that consider legislation affecting the military are:

- Separate House and Senate Veterans' Affairs; Armed Services, Appropriations, Defense and Military Construction – VA subcommittee. Below are FL members of the respective committees.

 - House Appropriations Defense and Military Construction – John Rutherford (R-FL), Scott Franklin (R-FL), Debbie Wasserman-Schultz (D-FL).
 - Senate Appropriations Defense and Military Construction subcommittee - None.

- Prime from \$363 to \$372/annual individual; family from \$726 to \$744.
- Select from \$177.96 to \$191.92; family from \$355.92 to \$364.92.
- Specialty co-pays from \$38 to \$51.

Expect a 2025 "Storm the Hill" effort in April by your MOAA team in Washington DC. They will be meeting with individual members of Congress on our behalf. More details in the March and April editions of *Military Officer*, our MOAA monthly magazine.

Don't forget – Our Florida legislature meets on 3 March 2025. Visit the FDVA site at floridavets.org. If you are a recent FL resident, you should be aware of the many state-sponsored veterans benefits available to you Use MOAA's Legislative Action Center to contact your lawmakers and urge them to support these legislative initiatives. For your convenience, there is a partially filled out form for each legislative priority. You can edit this form, adding or deleting content. You then select our representative (Ana Patricia Luna) and our Senators Ashley and Rick Scott. The email will automatically be sent to their offices.
